THAT ANY REGULARLY ORDAINED MINISTER OF THE GOSPEL, AUTHORIZED BY THE RULES AND USAGES OF THE CHURCH OR DENOMINATION OF CHRISTIANS, HEBREWS, OR RELIGIOUS BODY OF WHICH HE MAY BE A MEMBER, OR ANY JUDGE OR JUSTICE OF THE PEACE,
